

What's the Difference Between Morality and Ethics?

- Generally, the terms ethics and morality are used interchangeably by ethicists (philosophers who study ethics), although a few different communities (academic, legal, or religious, for example) will occasionally make a distinction.
- Morality and ethics have to do with distinguishing the difference between "good and bad" or "right and wrong."
- Many people think of morality as something that's to do with personal standards of behaviour, whereas ethics is the standards of "good and bad" distinguished by a certain community or social setting, e.g. you may not give to charity as you think there should be enough public money to give to important causes, but your company may give money to charities and encourage employees to volunteer. Your personal morality would contradict the ethics of your employer.








Oil spill – "Deepwater Horizon" platform

- April 20th 2010, Gulf of Mexico
- Explosion and massive oil spill at "Deepwater Horizon" oil well owned by BP, rig owned by Transocean, subcontracted to Halliburton & Cameron
- Largest accidental oil spill in history
- 11 workers killed
- The oil flowed for over 85 days
- 572 miles of shoreline covered with oil slick which spread across 43,000 miles of land and ocean
- Cost the lives of thousands of birds and marine species
- Tourism and livelihoods of fishermen devastated
- BP estimated costs >\$53 billion
- Made into a Hollywood disaster film in 2016











Real life business ethics — look at the pictures. What do they show?

Cheap labour in 'sweatshops'

- Cheap clothes and other goods for fashion-conscious western markets
- Low wages and working conditions are hard health, safety and hygiene often poor
- An investigation into Primark in 2008 revealed that Indian children as young as 11 were working in squalid conditions, sewing tiny beads and sequins onto cheap t-shirts by candle-light
- Following a BBC investigation, Primark stopped working with a number of factories
- Primark has been investigated repeatedly, including for unethical practices in the UK
- 2013 Rana Plaza disaster, Bangladesh an eight-storey complex of garment workshops collapsed, killing more than 1,000 people - Primark, Benetton, Mango, Matalan and others were all using their services
- The Modern Slavery Act (2015) requires UK businesses with a turnover >£36m to prove they have taken steps to ensure there is no slavery or human trafficking in their supply chain

Case: Politically correct name change?


